Supplemental Report on Performance on Select Exit Standards during
January – March 2014

Dear Judge Hogan:

At the January 24, 2014 status hearing, the District requested and the Monitor agreed to provide two reports in advance of the July 17, 2014 hearing. The first, which has already been provided, is the full monitoring report for the period July 1, 2013 to December 31, 2013. This second supplemental report provides additional data on select Exit Standards from the *LaShawn A. v. Gray Implementation and Exit Plan (IEP)* for the months of January through March 2014. The Exit Standards selected for this supplemental report were requested by CFSA as some of the areas that remain to be achieved and for which the Monitor would be able to relatively quickly verify the performance data provided by CFSA.

Attached is a summary table of the performance data on the selected standards reprinted from the last full monitoring report (July through December 31, 2013) and in the subsequent first three months of 2014. For each of the 13 Exit Standards assessed, we have also indicated the direction of performance change in the first quarter of 2014. It is important to note that there are 88 standards in the IEP of which 23 remain to be achieved. Thirteen of the 23 are discussed in this report; the additional 10 standards that remain to be achieved and are not discussed in this supplemental report will be reviewed in the next full monitoring report, due to be provided to the Court in November 2014.

The Exit Standards addressed in the supplemental report include:

1. *Timely Initiation of Investigations* – 95% of all investigations will be initiated within 48 hours or there will be documented good faith efforts to initiate investigations whenever the alleged victim child(ren) cannot be located (IEP citation I.A.1.a.).
2. *Timely Completion of Investigations* – 90% of investigations will be completed and a final report of findings shall be entered in FACES.NET within 35 days (IEP citation I.A.1.b.).
3. *Comprehensive Review on New Investigations with Four or More Reports* – 90% of the case records for families subject to a new investigation for whom the current report of child maltreatment is the fourth of greater report of child maltreatment, with the most recent report occurring within the last 12 months will have documentation of a comprehensive review (IEP citation I.A.1.c.).
4. *Social Worker Visitation for Children Experiencing a New Placement or Placement Change* – 90% of children newly placed in foster care or experiencing a placement change will have four visits in the first four weeks of a new placement or placement change as described (IEP citation I.A.6.a.-c.).
5. *Visitation between Parents and Workers* – 80% of parents will have twice monthly visitation with workers in the first three months post-placement or there will be documentation that the parents are unavailable or refuses to cooperate with the Agency (IEP citation I.B.10.).
6. *Visitation between Parents and Children* – 85% of children with the goal of reunification will have weekly visitation with the parent with whom reunification is sought or there will be documentation that a visit is not in the child’s best interest, is clinically inappropriate or did not occur despite the Agency’s efforts (IEP citation I.B.11.).
7. *Reduction of Multiple Placements for Children in Care* – Children served in foster care shall have two or fewer placements; different performance levels are required based upon the length of time children are in care (IEP citation I.B.13.).

8. *Timely Approval of Foster/Adoptive Parents* – 70% of homes licensed beginning November 1, 2010, will have been approved, and interested parties will be notified within 150 days or there is documentation that the delay (beyond 150 days) is due to something beyond the Agency’s control (IEP citation I.B.14.).
9. *Community-based Service Referrals for Low & Moderate Risk Families* – 90% of families who have been the subject to a report of abuse and/or neglect, whose circumstances are deemed to place a child in their care at low or moderate risk of abuse and neglect and who are in need of and agree to additional supports shall be referred to an appropriate Collaborative or community agency for follow-up (IEP citation I.C.19.).
10. *Health Screenings for Children in Foster Care prior to Placement* – 95% of children in foster care shall have a health screening prior to an initial placement or re-entry into care and 90% of children in foster care who experience a placement change shall have a replacement health screening (IEP citation I.C.22.a.).
11. *Full Medical Evaluations for Children in Foster Care* – 85% of children in foster care shall receive a full medical evaluation within 30 days of placement and 95% of children in foster care shall receive a full medical evaluation within 60 days of placement (IEP citation I.C.22.b.i.).
12. *Full Dental Evaluations for Children in Foster Care* – 25% of children shall receive a full dental evaluation within 30 days of placement; 50% of children shall receive a full dental evaluation within 60 days of placement; and 85% of children shall receive a full dental evaluation within 90 days of placement (IEP citation I.C.22.b.ii.).
13. *Receipt of Medicaid Numbers and Cards* – 90% of children’s caregivers shall be provided with documentation of Medicaid coverage within 5 days of placement and Medicaid cards within 45 days of placement (IEP citation I.C.22.d.).

Below the Monitor summarizes the supplemental findings by substantive area of the *LaShawn* IEP. Overall, the data point to continued progress as there were improvements in seven of the 13 Exit Standards reviewed for this three month period.

Summary of Findings:

Investigative Practice and Referrals for Community-based Services:

Four *LaShawn* Exit Standards related to investigations are included in this report. Two of the standards showed continued improvement and performance data for two of the three months met the IEP Exit Standard (*IEP citation I.A.1.c.* – completion of comprehensive reviews of the case history and current circumstances for families who are subject to a new investigation for whom the current report of child maltreatment is the fourth or greater report with the most recent report occurring within the last 12 months and *IEP citation I.C.19.* – community-based service referrals for low and moderate risk families).¹

Performance on initiating investigations with 48 hours (*IEP citation I.A.1.a.*) remained unchanged with between 88 and 91 percent of investigations initiated within 48 hours between January and March 2014. This is slightly below the required Exit Standard of 95 percent performance.

Performance on the fourth measure of investigative practice included in this supplemental report – timely completion of investigations (*IEP citation I.A.1.b.*) – has declined since the July through December 2013 monitoring period. Compliance has steadily decreased between January and March 2014, and in March 2014, 48 percent of investigations were completed within 35 days and as of the last day of the month, 105 investigations were in backlog status, having been open for longer than 35 days. The Monitor thinks and CFSA agrees that this decrease in performance is related to caseload pressure in CPS investigative units. Although we have not yet validated the caseload data for this period, CFSA data for February and March 2014 shows a significant increase in the percentage of workers whose caseloads are above the required standard of no more than 12 investigations per worker.² CFSA noted the caseload decline in its reporting to the Monitor and immediately initiated steps to address the decline by hiring additional workers and

is currently reviewing the investigations open longer than 35 days to determine barriers as well as service needs for the families.

Visits:

Three *LaShawn* Exit Standards related to visits (*IEP citation I.A.6.a.- c.* – visitation between social workers and children when they are newly placed or replaced; *IEP citation I.B.10.* – visitation between social workers and parents; and *IEP citation I.B.11.* – visitation between parents and children) are included in this supplemental report. Performance data for the first quarter of 2014 show that visitation between parents and children with a goal of reunification has improved since the July through December 2013 monitoring period, increasing from a monthly range of 64 to 66 percent to a monthly range between January and March 2014 of 73 to 75 percent. Data show that worker visits to children during the first four weeks of placement and worker visits to parents with a goal of reunification continued at approximately the same level achieved during the previous monitoring period.

Placement and Placement Support:

Data for two *LaShawn* Exit Standards related to placement and placement support are included in the supplemental report (*IEP citation I.B.13.* – reduction of multiple placements and *IEP citation I.B.14.* – timely licensure of foster parents). The Exit Standard related to placement stability has three subparts, reflecting differing levels of expected performance for children in care for different periods of time (12 months or less, between 12 and 24 months and greater than two years). CFSA's performance on the sub-part related to children in care for two or more years has been at or above compliance levels as since January 2011 and was maintained in this three month period. Additionally, during the first quarter of 2014, CFSA data show improvements to compliance levels in the second sub-part of this Exit Standard which requires that children served in foster care during the previous 12 months who were in care for at least 12 months but less than 24 months have two or fewer placements. These improvements in the reduction of multiple placements for children in CFSA care for two years or less are the result of changes to the placement process which allow for better matching caregivers and placement settings to children's needs and improvements in the availability of supports for caregivers which promote stability of placement.

CFSA also continues to demonstrate improvement and has performed at required levels in the first three months of 2014 in timely approval of foster parents, reaching 74 percent of homes licensed within the required 150 day timeframe. This is a considerable improvement from the data for the last half of 2013 which showed 59 percent of homes achieving timely licensure.

Well-Being:

January through March 2014 performance data for four health and dental care *LaShawn* Exit Standards are included in the supplemental report (*IEP citation I.C.22.a.* – health screening prior to placement, re-entry or replacement; *IEP citation I.C.22.b.i.* – full medical evaluation after placement; *IEP citation I.C.22.b.ii.* – full dental evaluation after placement; and *IEP citation I.C.22.d.* – caregiver receipt of Medicaid number and card).

CFSA has made some improvement in the monthly range of performance toward completion of initial, re-entry and replacement health screenings and timely comprehensive medical evaluations. Completion of full dental evaluations within 90 days of placement has declined slightly to the lower level of monthly performance found in the July through December 2013 monitoring period with a monthly range between January and March 2014 of 78 to 80 percent; this sub-part of the full dental evaluation Exit Standard requires 85 percent. There was no change in performance on receipt of Medicaid number or cards, although CFSA reports that they have recently developed a new process with the Department of Human Services to issues Medicaid cards timely.

Amendments to May 2014 Progress Report:

Subsequent to our providing the Court with the progress report for the July through December 2013 monitoring period, CFSA provided supplemental data for two Exit Standards. These corrected performance data will be included in subsequent reporting and are detailed below for notification to the Court:

- *IEP citation I.C.22.d. – Receipt of documentation of Medicaid coverage*
The monitoring report indicated that in August 2013, no applicable foster parents received the child's Medicaid number within five days of placement. Based upon supplemental data provided, compliance in August 2013 is 81 percent.³
- *IEP citation I.B.11. – Visitation between parents and children*
The monitoring report provided that in December 2013, 66 percent of applicable children had weekly visits with their parents. Based upon the supplemental data provided, compliance in December 2013 is 65 percent.⁴
